## **Burscough Dynamos**

A community based club, providing football opportunities for children and young people. They raise funds through monthly subscriptions and occasional fundraising events. **The grant of £2400 was awarded for the refurbishment of the community room and pavilion including new flooring, lighting and heating.** The room and pavilion are now available for hire within the local community as well as by its members.

## **Provision of a new bus shelter**

A new bus shelter was commissioned by the Parish Council. The shelter was supplied and installed by B&C Shelter Solutions Limited on **Liverpool Road South, Burscough, L40 7RS**. The work was carried out in April 2017.

## **GrantScape (white moss): New picnic/play areas**

It was decided that land adjacent to the canal and owned by Burscough Cricket Club would be converted into a new picnic and play area. This picnic and play area is public, for use by Burscough residents and the wider community. **The Parish Council was asked to contribute £2107** to complement the award of £18865 already secured by the cricket club from GrantScape. The work was completed in the middle of 2018.

## **Mere Avenue: replacement playground equipment, safety surfacing and fencing**

At the Parish Council meeting of 12/07/2017, it was agreed that expenditure be committed for the Mere Avenue play area. Yates Playgrounds Ltd were contracted to deliver the project, which would be met from a combination of precept, S106, a WLBC capital grant, CIL (£3000) and general reserves.
