#### **MINUTES**

#### 250. Welcome

The Chairman opened the meeting with a warm welcome to all Councillors, residents and Borough Councillor. It was agreed to move Network Rail Consultation on Train Services into Manchester up the agenda.

- 251. Apologies
  - Apologies were received from Cllr's Bailey and Booth; these were accepted by the Councillors present at the meeting.
- 252. <u>Disclosure of Pecuniary Interest and Non-Pecuniary Interest</u> Cllr Crawford item 14 on the agenda.
- 253. Network Rail Consultation on Train Services into Manchester

Cllr Bell gave a brief overview regarding the public consultation addressing the performance of the network into Manchester (including associated stations) and time delays with linking train networks. It was noted that OPSTA had done a number of surveys and discussed with passengers their views regarding this route and were asking for support from Parish / Town Councils in West Lancashire to respond to this consultation. Cllr Crawford commented at the meeting that people with disabilities can be inhibited whilst travelling and more is needed to be done to support their needs in the future.

It was resolved for CIIr Bell to provide a response on behalf of the Town Council to be circulated before submission. This was proposed by the Chairman and seconded by CIIr Crawford with a unanimous vote.

254. Previous Minutes of the Full Town Council Meeting held on 20<sup>th</sup> January 2021 Cllr's received a copy of the minutes prior to the meeting. It was resolved that minutes of the full Town Council Meeting dated 20<sup>th</sup> January 2021, were approved. These were proposed by Cllr Ryley and seconded by Cllr Crawford with a unanimous vote to be duly signed by the Chairman when he next attends the Town Council Offices. (Coronavirus Act 2020)

## 255. Co-Option

It was resolved to co-opt N Pollington (Ellerbrook Ward) onto the Town Council this was proposed by the Chairman and seconded by Cllr Bell with a unanimous vote.

- 256. Presentation Sophie Moeng Consultation Manager Network Rail
  Network Rail presentation, Sophie Moeng introduced herself to the Town
  Council Borough Councillor and resident. It was noted that this was her
  second presentation to the Town Council. The purpose being to update the
  Town Council on progress made so far regarding consultation to alterations at
  the Crabtree Lane Crossing, to permanently close to all vehicles and install a
  new pedestrian crossing. She informed the following: -
  - Consultation start date was on schedule to start on the 15<sup>th</sup> February 2021.
  - Brochures regarding the proposals had been sent out to residents within 1km radius of the Crabtree Lane Crossing.
  - Posters had been installed at either side of Crabtree Lane Crossing providing information.
  - The dedicated email in box address was now in operation for comments from residents.

  - The dedicated website <u>www.networkrail.co.uk</u> was now operational.
  - There would be plans if agreed following the consultation process to clear the entrance to footpath FP 8-18-123, add a turning area after authorisation from land owners, installation of crash bollards, double yellow lines laid and compensatory planting.

The Chairman thanked Sophie Moeng for her attendance and keeping the Town Council informed.

# 257. Comments from Borough and County Councillors Cllr Pope commented:-

- Highways have plans to start the usual road repairs from March 2021.
- Marking of new cycle paths have been identified within the Burscough and Ormskirk area and were now available.

#### 264. Litter Picking
